# Making A Difference, One Life at a Time

Rebekah Walker has pursued her life-long career as an artist well into retirement. Drawing, painting and teaching, she has been active in many programs Ms. Halladay was throughout the years. In 2009, diagnosed with glaucoma, Mrs. Walker needed new glasses but was not able to afford them. Under current plans, seniors who have Medicare do not have routine optical coverage unless they hold a supplemental policy. For Mrs. Walker and many other area seniors, there is simply no room in a monthly budget to afford a health plan that provides full care without sacrificing utilities, food and prescription medication. Fortunately for Rebekah, Pam Halladay, Senior Program Officer at the Hannan Foundation in Detroit, knew where to go for help: the American House Foundation.

With approval of a grant for \$338.00, able to provide Mrs. Walker an eye examination and two pairs of glasses. Now she can see clearly again, and is able to enjoy and share with the community, the beauty of her art work.

# Resources for Today, Research for Tomorrow

A recent study by the National Association of Area Agencies on Aging found that less than half of American communities are prepared to adequately address the needs and assets of a population that is growing older. Seniors Count!, a project funded by the American House Foundation along with the Kresge Foundation and the Community Foundation of SE Michigan is investigating and recording vast amounts of demographic data about our aging population. Modeled after the national program KIDS COUNT!, this project will

provide the information necessary to help communities and businesses prepare for the coming age wave. The American House Foundation dedicates 30% of its funding to research at the Institute of Gerontology at Wayne State University. "Without a strong understanding of the problems that seniors face, and solutions to address them, we will not be effective in improving the quality of life for older adults in our community," says Robert Gillette, Chairman of the Board.
